- Be transparent and have integrity




## How your gift could help

### Gifts in wills explained

Making a will can be a powerful act, bringing peace of mind that your loved ones are provided for in a way of your choosing. Leaving a gift to charity in your will can help to provide for your community in this same way which is why many people now choose to leave a legacy donation to a charity or cause which is important to them in their lifetime.



You may be surprised to know that leaving a gift to a charity in your will has many other benefits, both to you and to the charity you choose. Not only are you making sure that a charity close to your heart is able to continue its valuable work, but you are also reducing your taxable assets, potentially reducing the rate of your overall inheritance tax.



What this means is that as inheritance tax is taken after the gift to charity has been donated, your total taxable assets are reduced thus reducing the amount of tax deducted.

As the gift is not taxable, 100% of your donation goes to your chosen charity, which makes it one of the most effective ways of donating as there are very limited expenses on either side.

## Where do I start?

Making a will can be a daunting prospect but in practice it can actually be quite simple. This guide gives you three easy steps to writing your will from start to finish:

1. Consider who or what you would like to leave a gift to

- 2. Choose your solicitor and executor and book an appointment
- 3. Write down your wishes and sign with your chosen representative

### Key terms:

**Solicitor:** A legal representative or practitioner who deals with matters of law

**Executor:** Someone (usually a trusted friend or family member) who is responsible for implementing the wishes stated in your will.

You can now write your will with a solicitor or using an online will-writing company. There are pros and cons to both. You may need to seek advice to find out which is the best option for you.



## Types of gift in your will

There are four main types of gift you can leave in your will:

### A residuary gift

A percentage of your estate once any specified gifts have been made. Many people choose to leave this type of gift because its value will be dependent on the value of your estate at any given time rather than a set amount.

### A pecuniary gift

A specific amount. It's worth bearing in mind that the effects of inflation mean that this type of gift is likely to lose value over time and may end up being less than you initially intend.

### A reversionary gift

With a trust someone can enjoy the benefit of money or property during their lifetime. Afterwards, you can choose for the remaining money or property to be donated.

#### A specific gift

A gift or a specified item – such as a personal possession, land, buildings or stocks and shares.

### FAQs

### **\*\*** Does Intercom Trust really need a gift from me?

Absolutely! The majority of our services are offered for free to anyone and the number of people we support is growing year on year. For example our 1-2-1 Support and Advocacy Service was accessed by record numbers of people last year and continues to grow. By donating you can help us to achieve so much more.

### Do I need a solicitor?

You can write your own will; however, to ensure that it is legally binding and covers everything you would like it to, we would always recommend a solicitor. This is because a professionally written will is more likely to accurately convey your wishes, and it offers an externally authenticated paper trail to prove its legitimacy.

### If I do leave a gift, how will you find out?

Your will is private, and we won't know if you have left us a gift unless you choose to tell us – or until the time comes for your will to be read. However, if you have chosen to leave us a gift, we would love to know so we can thank you and stay in touch in the way that suits you best.

### 🗧 What about Inheritance Tax?

Leaving a gift to us – or any other charity – may lower your overall Inheritance Tax liability. If you leave over 10% of your estate to charity, you may be eligible to pay a reduced IHT rate. Every case is different, so it is best to speak to your solicitor about it.

### l've just written my will. Do I have to do it all again if I want to leave you a gift?

No. Rather than re-writing everything you can instruct a solicitor to add an amendment to your existing will – which they will then prepare. This is known as a codicil.

### What is the process of writing a will?

Most wills are straightforward, but it depends on individual circumstances: for example, if you would like to leave some of your estate in trust. For either simple or complex wills, the process begins with an appointment with your chosen or existing solicitor.
